Official Terms and Conditions

1. TO ENTER: visit any Coast Tire & Auto Service Centre in Atlantic Canada. Visit www.coasttire.ca for location details. For every purchase, CAA Members will be automatically entered.
2. Contest starts at 12:00 a.m. AST on May 1, 2009 and closes on August 31, 2009 at 11:59:59 p.m. AST (the "Contest Period"). There is one (1) Grand Prize to be won from all the eligible entries received during the Contest Period. Void where prohibited.
3. CAA Maritimes Ltd and Coast Tire & Auto Service hereinafter referred to as the "Contest Sponsors".
4. To enter and to be eligible to win, entrant must be a legal resident of Nova Scotia, New Brunswick, Prince Edward Island or Newfoundland and Labrador and be over the age of majority in his or her province of residence. Employees and their parents, siblings and children, and persons domiciled with an employee of any of the Contest Sponsors, their agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, and promotional and advertising agencies and administrators, are ineligible to enter. Gift certificates expire December 31, 2009. Gift certificates can be used at any Coast Tire & Auto Service location. Taxes and levies are not included. Prize is non-transferable, must be accepted as awarded, and may not be redeemed for cash. Estimated value of each monthly prize is approximately \$207.89.

The Grand Prize consists of a three (3) night stay for two (2) people including airfare from Halifax International Airport to New York, NY, USA, October 9-12 2009, airport transfers while in New York, \$200.00 spending money and three (3) nights accommodations as chosen by the contest sponsors. The first entry drawn will be eligible to win the monthly Prize. The odds of winning the monthly Prize will depend upon the total number of eligible entries received during the monthly Contest Period. On or before September 3 2009 at 9:00 a.m. AST, a random draw will take place at Coast Tire & Auto Service, Somerset Square, Saint John, NB, from among all eligible entries received during the Contest Period. The first entry drawn will be eligible to win the Grand Prize. The odds of winning the Prize will depend upon the total number of eligible entries received during the Contest Period.
